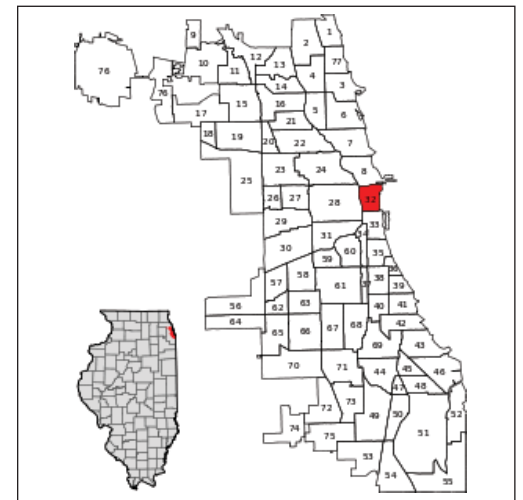
## The Loop
